Annual Meeting Highlights

The 2023 NCC Annual Meeting of members was held at NCC in Ray on Tuesday, June 20, 2023. A delicious picnic style meal was served by the NCC employees to over 325 people at the NCC warehouse. Prior to the business meeting, DMJ, a mother-daughter duo from Williston entertained the crowd. About 39 children enjoyed the kids' activities, including inflatables and the Kidz Korner where kids were able to try out some Virtual Reality Goggles. Members were encouraged to visit the demonstration booths including a Virtual Reality Experience, myNCC Connect App, a 3D printer, SmartHub and new this year was a touch a truck type demo of the Ditch Witch equipment used at NCC.

The business meeting was called to order by President AJ Cvancara at 6:00PM. Jennifer Gjovig, Legal Counsel reported on By-laws changes. Jen Bingeman reported on the co-op's audited financial state at the end of 2022. NCC had a strong year financially generating a net margin of just under \$4 million. Two directors, AJ Cvancara, District #3 representing Alamo, McGregor, Noonan and Wildrose and Jim Simonson, District #7 for Crosby were re-elected to a three year term to the Board of Directors. General Manager/CEO, Jeremy Becker stated that 'connectivity is a necessity' and again mentioned that NCC continues to see the demand for Internet climb as the applications and uses for it continue to multiply. Broadband usage has increased by 180% from 2017 to date with 89% of the network traffic consisting of streaming video and social media applications. Becker welcomed the Portal exchange into the cooperative and mentioned that plans for construction are set to tentatively begin this Fall with cutovers in the members' homes in 2024. He was happy to announce that the NCC Board of Directors approved a \$1.5 million general retirement for 2023. Members having done business with NCC in 1996, 1997 and/or 2022 will see a check in the mail sometime in the August timeframe. Many prizes were given away throughout the meeting. The grand prize of \$500 cash was won by Gary Reinholdt of Epping. Kids grand prizes of a Hoverboard and Playstation 5 were Mylee Dosch of Powers Lake and Briggs Vejtasa from Tioga. Notice About Your Account

Federal law allows us to use information from your current records to market and advise you of new products and services that may satisfy your communications needs, unless you notify us otherwise.

What is this "information?" It is information called "Customer Proprietary Network Information" or "CPNI" - relating to telecommunications services you receive from NCC.

How can we use this information?

This information can be used to advise you about innovative communications services or new communications technology and products offered by NCC. We DO NOT sell or in any way provide this information to any other company other than the 911 records we are required by law to provide if you are a telephone customer.

Who will be able to use this informa-

tion? ONLY Northwest Communications Cooperative and the subsidiary companies of NCC can use this information.

Will NCC protect my information?

YES! You have the right, and we have the duty, under federal law, to protect the confidentiality of this information. Therefore, regardless of whether you consent or not, to allowing us to continue providing you with educational mailings, your account will be treated confidentially.

What action is necessary on my part to show consent? No action on your part is necessary. If you do not contact us within 30 days and indicate that we may not continue providing you with marketing and educational mailings, we will continue to do so.

Capital Credits

STEP 2

At the end of each year, NCC completes its financials and year-end margins are assigned proportionately to the members based on total services provided to all members.

HOW DO CAPITAL CREDITS WORK?

Capital credits for co-op members result from a surplus of funds remaining from doing business. As a local telephone, internet or video subscriber, you are automatically a member/owner of NCC. Each time you pay your bill, you're making an investment in a company you and your neighbors actually own.

When financially feasible, NCC's board votes to perform a capital credit retirement. This is a payout which reduces a portion of the members capital credit balance based on the years of service being retired.

Being a Member Pays! NCC to disburse \$1.5 million in capital credit dividends this summer.

We are excited to announce that as a cooperative member-owner, you could be receiving a dividend check as a part of our capital credits program!

THE COOPERATIVE BENEFIT As a member-owned cooperative, the credits represent each member's ownership of NCC. Capital credits are the margins credited or allocated annually by the NCC Board of Directors to the members of the cooperative based on their purchases from the cooperative the previous year. These margins are used by the cooperative as capital to operate the business for a period of time. Based on the financial condition of the cooperative, any excess is returned to the members in the form of capital credit dividends.

MEMBER ELIGIBILITY OF DIVIDENDS The \$1.5 million retirement will be distributed to members doing business with the cooperative in the years of 1996, 1997 and/or 2022. Both longstanding and new members will receive a check to be sent out in the August timeframe. Please make sure the address on file with us is current and report any changes to NCC at 701-568-3331.

Rural Development Finance Corporation (RDFC) Grant:


NCC and the other Rural ILECs in ND are given \$3,000 to distribute to community owned entities, non-profits and other community-based projects. The minimum grant amount is \$500; the maximum is \$3,000. *Applications due October 13, 2023.*

About RDFC: RDFC is a non-profit corporation owned by North Dakota's electric and telecommunications cooperatives. NCC is a member of RDFC. RDFC's mission is to promote rural economic development, primarily focusing on creating new jobs and enhancing essential community services and facilities by providing affordable financing. They have larger loan programs that fund community-based projects and non-profit entities with low interest loans.
